## TRIAL INFO      **\*\* Entry\*\***

- Option 1 (preferred) PAPER ENTRY FORM & PAYMENT BY CHEQUE. Draw result will be published on our website and will be returned by post to you if you include an S.A.E.
- Option 2 EMAIL ENTRY & Payment via BACS 7 days before the trial. Entry form available on the club website. Preference is that they are typed and the document emailed rather than a picture. Email entries **MUST ONLY** be sent to this email address: **pembstrialentry@hotmail.com** you will receive a confirmation email (within a few days) that your entry has been received.  
**WhatsApp/phone entries will NOT be accepted.**

**Draws** will be published on the website and Facebook page, if you do not send an SAE it is your responsibility to look for the draw. Draws take place at FT Secs home 7pm, please contact FT sec if you would like to attend. **Payment** - Separate form and cheque for each trial payable to: **Pembrokeshire Working Gundog Society**, or payment by BACS min 7 days before the trial. **Directions** to the trial will be communicated with the draw (available on the website) or returned via S.A.E. **Start Time** – All Trials meet at **9.00am** for a **9.30am** prompt start – where reserves will be put in. **Withdrawals** – Reg J6f applies. After an applicant has been successful in a draw, or reserve accepted an offer of a run the applicant may be liable for the full entry fee. **Prizes** – Certificates & Appropriate trophies. **Trophies** must be returned 1 month before the trial – Failure to return a Trophy by this date will result in a fine of £50.00. Engraving of trophies is the responsibility of the holder. **Please clean trophies before return.**

## RULES AND REGULATIONS

1. Dogs entered at Kennel Club Licensed Field Trials must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.
2. The society may reserve to itself the right to refuse any entry. Persons who have been refused membership may not enter this society's Trials as owner or handler
3. **No substitution of dogs** while reserves stand.
4. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
5. If entries or nominations exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot.
6. Should circumstances dictate the society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to The Kennel Club.
7. No modification may be made to the schedule after publication except by permission of The Kennel Club, followed by advertisement in appropriate journals if time permits before the closing of entries.
8. Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership.
9. Videography and photography will only be permitted with the express permission of the Chief Steward and the host.
10. Welfare of Dogs An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial.
11. **DOGS IN CARS ON HOT DAYS** Your dog is vulnerable and **AT RISK** if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog(s). If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused. FT68/CAT Version 11
12. If a competitor, or anyone in their household, has Covid-19 related symptoms or has tested positive for Covid-19 they must follow Government advice and should consider whether it is appropriate that they attend the event.
